- * living or working in NSW (or an Aboriginal or Torres Strait Islander person living in specific NSW border areas), and
- * an Australian citizen, Australian permanent resident, Australian permanent humanitarian visa holder or New Zealand citizen;
- * or are a NSW apprentice or trainee

OUR GUARANTEE TO YOU

Are my fees protected?

Yes, The Grove Studios Academy has a responsibility to protect the fees paid by students. The Grove Studios Academy will only accept an initial payment of no more than \$1,500 from each student prior to the commencement of his or her course. This fee protection arrangement complies with national standards designed to limit the amount paid by a student's in advance of services being delivered.

If for any reason The Grove Studios Academy is unable to fulfil its service agreement with a student, The Grove Studios Academy must refund the student's proportion of fees paid for services not yet delivered.

How do I get a refund?

To obtain a refund you are required to give written notice to cancel your enrolment and complete a Refund Request Form.



DO I PAY GST ON MY FEES?

No – Training tuition fees are GST exempt under section 38-85 GSTR 2003/1 Goods and Services Tax, tax ruling. The ruling explains the supply of a course for 'professional or trade course' is a GST-free education course. GST does apply on the payment of some miscellaneous charges.

CHANGES IN TERMS AND CONDITIONS

The Grove Studios Academy reserves the right to amend the conditions of the student's enrolment at any time. If amendments are made that effect the student's enrolment the student will be informed 7 days prior to changes taking effect.



NOTES

- All training tuition fees are exempt from the payment of GST. No GST included.
- RPL (Recognition of Prior Learning) fees are for completing an individual unit of competency.
- The initial application/enrolment fee for RPL into the above qualifications is \$100 with the balance of the fee due at the completion of the RPL assessment process before any AQF certificate is issued.
- The fee structure described above is designed to limit the amount paid by students upfront and is structured to collect fees as the course progresses.
- All fees must be paid in full before students can be issued with any AQF Certificate relating to their achievements
